- Automatic Withdrawal Authorization Form: Use this form to switch any automatic withdrawals to your new account.
- Bill Pay: Once you have enrolled in our online banking service, you can switch over your payees.

- Account Closure Authorization Form: Use this form to authorize the closure of your old account. Verify that all your automatic transactions have been switched to your new account and any outstanding checks have cleared, and have any remaining balance sent to you or to your new account at LAPFCU.
