- a. By signing this Affidavit of Domestic Partnership, we agree that we are in a committed and mutually exclusive relationship in which we are jointly responsible for each other's welfare and financial obligations.
- b. We are not married to anyone else.

- d. We are each other's sole domestic partner and intend to remain so indefinitely.

I agree to provide a copy of the Statement of Termination to my former domesticpartner. I understand that I cannot file another Affidavit of Domestic Partnership with you until twelve (12) months after the Statement of Termination of the previous partnership has been filed.
- f. We understand that if Los Angeles Police Federal Credit Union suffers any loss because of a false statement contained in this Affidavit, Los Angeles Police Federal Credit Union may bring a civil action against either or both of us to recover your losses, including reasonable attorney's fees and court costs.
- g. We understand and agree that we are providing the information in this Affidavit solely to allow Los Angeles Police Federal Credit Union to determine our eligibility for services offered by Los Angeles Police Federal Credit Union. We understand that this information will be held confidential and will be subject to disclosure only upon our written authorization or pursuant to a legally appropriate process.
- h. We understand that in addition to the eligibility requirements of Los Angeles Police Federal Credit Union, there are terms and conditions of the Truth-in-Savings agreement and disclosure, other product agreements and disclosures, and loan agreements and disclosures, for the products and services offered by you. By executing this Affidavit, each of us agrees to be bound by the terms and conditions set forth in the agreements and disclosures for your products and services that we utilize.
- i. We understand that the information we are providing in this Affidavit may be used either by you or by us as evidence of the existence of our domestic partnership in subsequent legal or administrative proceedings. We understand that before signing this Affidavit, we should seek competent legal and/or tax advice concerning the financial obligations we may be undertaking by signing this Affidavit.
- j. We each declare, under penalty of perjury, that the assertions in this Affidavit are true and correct to the best of each of our knowledge.
- k. By signing below, we acknowledge receipt of our individual copies of this affidavit and acknowledge we have read and understand the total contents herein.
